DEAN'S DECREE No. 08/2020, determining the amount of scholarships awarded for full-time doctoral studies at the Faculty of Arts of the University of South Bohemia in České Budějovice

No: DFF/24/20

Article. 1 Basic definition

The scholarship awarded to students in a doctoral study programme is a scholarship paid from a contribution or subsidy OF the Ministry of Education, Youth and Sports of the Czech Republic pursuant to SECTION 91 (4) (c) of the Higher Education Act. The conditions of payment are further regulated by the Scholarship Regulations of the University of South Bohemia in České Budějovice of 16 May 2017, namely Article 13. The scholarship at the Faculty of Arts is awarded to students of doctoral programmes who study in full-time form of study and have not exceeded the standard length of study (all periods of previous unsuccessful studies in doctoral study programmes are included in the period study). The amount of the scholarship and the details of awarding the basic scholarship for students of doctoral study programmes are determined by the Dean's decrees, and the basic scholarship shall be awarded by an ex officio decision.

Article. 2 Organizational provision

- The scholarship is paid back to the student as a regular, monthly recurring amount throughout the year of study. The annual monthly amount is determined by the Dean's decrees. Unless an updated measure is issued, the current amount of the scholarship remains unchanged. The stipulated amount of the scholarship applies to all courses offered as part of the doctoral studies at the Faculty.
- 2. In addition to the regular basic scholarship, the Dean may, on the proposal of the Chair of the Doctoral Board of the given field/programme, grant the student a one-time one-off scholarship up to CZK 20,000 within the given academic year, for a significantly above-standard presentation of the results of his/her scholarly work (international conferences, publications, teaching in addition to the obligations arising from the individual study plan).

3. In the event that the regular evaluation of the student finds that he/she is not meeting the essential requirements of the individual study plan without giving serious reasons, the Dean may, on the proposal of the Chair of the Doctoral Board, individually reduce the basic doctoral scholarship for the student by up to 50 percent of its established amount. This reduction is effective from the following calendar month in which the Dean receives the proposal and is valid until the end of the academic year. The student shall be informed of this reduction in writing. Article. 3 Specific amount of basic scholarships in the academic year 2020/2021

1. For the academic year 2020/2021, the specific amount of basic doctoral scholarships for students in full-time doctoral programmes with a standard period of study of four years who are eligible for the award of this scholarship shall be determined as follows:

Students studying

- a) in the first year of study are granted a scholarship of CZK 9,000 per month;
- b) in the second year of study are granted a scholarship of CZK 9,500 per month;
- c) in the third year of study are granted a scholarship of CZK 10,000 per month;
- d) in the fourth year of study are granted a scholarship of CZK 10,500 per month;

Article. 4 Concluding provisions

This Decree shall take effect on 3 November 2020 and repeals Dean's Decree No 14/2018 of 12 October 2018. Students in existing three-year doctoral programmes shall retain the basic scholarship (also for their fourth year of study) at the amount previously set by the individual Doctoral Boards for their respective fields of study, i.e. CZK 3,000 per month.
