Study obligations			
<p>The basis of doctoral studies is the completion of compulsory courses with an emphasis on independent scientific work, both in the form of dissertation preparation and other activities, especially publications, presentations at international conferences or involvement in the pedagogical activities of the Institute of Archaeology of the Faculty of Arts, University of South Bohemia in České Budějovice. It is also an obligation to complete a study stay of at least 1 month at a foreign university or other scientific workplace, or to participate in a foreign research project.</p> <p>An integral part of the study plan is the completion of compulsory elective courses of thematic focus. Within their framework, each student is obliged to complete 3 basic methodological courses out of a total of 4 offered (block A), covering the basic specializations of archaeology studies at the Faculty of Archaeology - prehistory, medieval, theoretical and environmental archaeology. In each course, the emphasis is on teaching the latest methodological trends of a given chronological or thematic area. Another obligation is to take an exam in two world languages from the faculty-wide offer (block C). #### Requirements for creative activities

The curriculum also includes a separate creative activity, which is included in two courses:

- 1) In the courses Professional and Scientific Activity I-V the student is obliged to actively participate in an international conference, i.e. either to give a lecture in a foreign language or to present a poster in a foreign language.
- 2) An article in a peer-reviewed journal I-II, which must be published or at least accepted for publication. The article must bring new results of the PhD student's scientific work and must undergo a proper review procedure. At least one article should be published in a foreign or domestic periodical of the JScop format, or JImp. In both articles, the student must be the sole or main (first) author.

However, the student's own creative activity will focus on the preparation of a doctoral dissertation. Its form and other formalities are laid down in Article 8, article 8 and Article 8 of the Basic Regulation. 1, Order of Doctoral Studies at the Faculty of Arts JU (Dean's Measure No. 14/2013).

#### Internship requirements

As part of the compulsory course "International Cooperation", the student is obliged to complete at least a one-month (20 working days) internship, with a preference (in the case of full-time study) for a three-month stay at a selected foreign university or other workplace (according to individual consultation with the supervisor). Scholarships or projects provided by the JU (e.g. Erasmus) may cover the financial support for the internship. At the end of the internship, the student will demonstrate the results obtained during the internship through a presentation at a doctoral seminar and a written report that will be part of the student's report to the departmental board. The specific content of the foreign internship will be determined in agreement with the supervisor. Exceptionally, in the case of a combined form of study, a foreign internship can be replaced by the participation of a student in a foreign research project.

#### Other study obligations

The subjects Professional and Scientific Activities I-V also include the student's teaching duties, i.e. conducting selected lectures, seminars or other participation in teaching or participation in field or laboratory archaeological practice (possible independent conducting of field archaeological practice is possible only in accordance with Act No. 20/1987 Coll., i.e. with the condition of completing a master's degree in archaeology with a minimum of two years' experience in the field).
