3.6 Significant applied research results with an impact other than an economic one on society

The main results of application character with non-economic impact of the Faculty of Arts, University of South Bohemia:

From the perspective of FA USB, these are the five main results of application character with non-economic impact, which cover main areas of research cultivated at the faculty (literary scholarship, linguistic and historical research, archival research, archaeology, heritage care, museums, gallery practice, translation and mass media):

 - a) Public database "Czech Literature in translation in 1989-2020" (with Moravian Library in Brno)
 - b) Public database "Reception of World Literature in Czechia in 1989-2020" (with Moravian Library in Brno)
 - c) A specialised map of the reception of world literature in Czechia in 1989-2020 (with Moravian Library in Brno)
 - d) A collective monograph summing up the results of the research "Transfers of reception: Czech literature Abroad and World Literature in Czechia in 1989-2020"
 - e) A workshop "Concepts, Sense and Meaning in a Literary Text"
 - f) An international scholarly conference "Reception of Czech Fiction Abroad and World Fiction in Czechia in 1989–2020"
- 2. Results of the Czech-Bavarian project of trans-border partnership From Tradition to Future. Linguistic and Literary Heritage of East Bavaria and South Bohemia as the Focus of University Partnership:
 - a) A bilingual publication focused to capture linguistic and literary aspects of the border region "From Traditions to Future. Linguistic and Literary Legacy of East Bavaria and South Bohemia as the Focus of University Partnership", the content of which is implemented in the form of study materials.
 - b) A bilingual database mapping the language situation on the Czech-Bavarian border before 1946 and after, the change of Czech and German proper names, both personal and local, major writers of East Bavaria and South Bohemia and ways of co-existence in the area between Passau and Budweis.
 - c) A bilingual mobile application an uncluttered and structures provision of data summed up in the database quoted above for Apple and Google Play
 - d) Workshops six joint workshops and an international conference, on which linguistic and literary aspects of the border regions were presented
